

Key Congressional Committees and Their Functions

The following are a list of the key Congressional committees in both the House and Senate chambers. As part of a new grassroots outreach program, NAHMA is providing our members with a brief introduction to these committees, as well as listing the members of both parties. These lists of members are provided so that individual members can see who to contact when important affordable housing issues come to the forefront of one of these committees. NAHMA members may then contact their individual Representative or Senators to alert them of the importance of a particular issue.

To determine who your Representative is, click on the [House of Representatives website](#) and in the upper left hand corner fill in your zip code in the “Find your Representative” section. Some zip codes require the additional 4-digit mailing code and the [USPS website](#) provides a search service to obtain those additional 4-digits. To determine who both of your Senators are (remember each person and state are represented by 2); [click here](#) to see a listing of Senators.

The Senate and House Committees on Appropriations

The Committees on Appropriations are responsible for determining how much of the budget should be allotted to each department and program within the government. They are also responsible for rescinding appropriated money and transferring unexpected balances. Their responsibilities also include providing new funding authority for new bills and joint resolutions reported by other committees. They hold the key to ensuring that affordable housing programs within HUD and the RHS are funded adequately. For this reason, NAHMA considers them among the most powerful committees on Capitol Hill.

The Senate Committee on Banking, Housing, and Urban Affairs and the House Committee on Financial Services

This Committee has oversight responsibility of HUD and the Rural Housing Service. As the appropriate “authorizing committee” for housing issues, consideration of most new housing-related legislation in the House begins here. The Senate Subcommittee on Housing, Transportation, and Community Development and the House Subcommittee on Housing and Community Opportunity specifically handle matters related to public, affordable, and rural housing, as well as community development. NAHMA is especially interested in increasing our grassroots efforts with these members so that we may continue to reform HUD programs that affect our affordable housing managers.

Senate Committee on Finance and the House Committee on Ways and Means

NAHMA is concerned with these committees because they are responsible for writing tax laws. With the growing effort to preserve affordable housing through various tax programs that are regulated through the IRS and not HUD, these committees are increasingly important to NAHMA members. Specifically, the Senate Subcommittee on Taxation and IRS Oversight, and Long-Term Growth and the House Subcommittee on Select Revenue Measures deal with exit tax relief, low-income housing tax credit and tax exempt bond financing issues.
