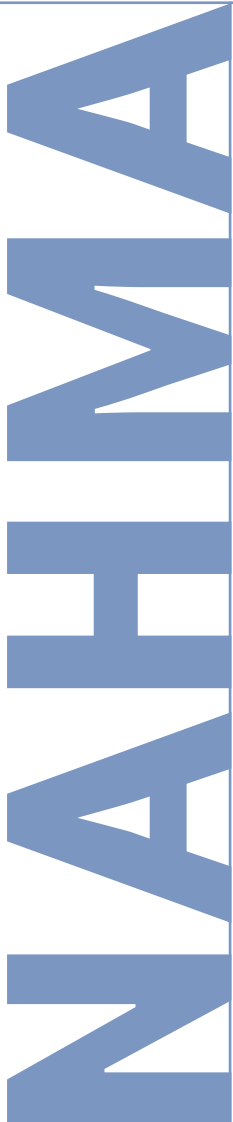


# NAHMA Affiliate Members
