Update on Multifamily Headquarters Transformation

Background

As part of HUD's nationwide transformation of its Multifamily Housing field offices, the Department is also reorganizing the Office of Multifamily Housing in the Washington D.C. headquarters. The reorganized structure places all operations into four main offices under the Office of Multifamily Housing:

- The Office of Multifamily Production;
- The Office of Asset Management and Portfolio Oversight;
- The Office of Recapitalization; and
- The Office of Field Operations

During NAHMA's 2014 October meeting, the Deputy Director for the Office of Asset Management and Portfolio Oversight, John Hall, shared the following chart on the program authority structure and oversight divisions of each office. The Department has also recently released a chart which lists the names of some of the directors for each office as well as the directors for these offices' divisions. Additionally, HUD has issued a chart on the leadership of the new Southwest Region (Fort Worth hub, Kansas City satellite office), which includes the names of division directors and branch chiefs. All three of these charts may be found on the following pages.

These charts are labeled as draft documents, so NAHMA will supply follow up information on the final office structure details and director positions when they are made available. We will also distribute the leadership organization of other regions when they are released.






MFH headquarters organization




OAMPO Multifamily Asset and Counterparty Oversight Division






OAMPO Assisted Housing Oversight Division




OAMPO Business Relationships and Support Contracts Division
