PURPOSE/INTENDED OUTCOME:

This Administrative Notice (AN) is being issued to provide uniform and consistent Agency interpretation on issues regarding Community Facilities (CF) loans and grants for public safety and health care projects that have contractual arrangements to serve neighboring communities.

COMPARISON WITH PREVIOUS AN:

This AN replaces AN 4760 (1942-A, 1942-C, 3570-B, and 3575-A) dated April 2, 2014, which expired on April 30, 2015.

IMPLEMENTATION RESPONSIBILITIES:

We continue to receive requests for funding of public safety and health care projects that have entered into contractual agreements with neighboring communities to assist in case of a large fire or a significant health care event. Such an arrangement is acceptable and in harmony with the mission of an essential community facility.

The population of the areas covered under the contractual arrangement can be included as population served for these projects in the Commercial Programs Application Processing (CPAP) system of USDA. Please be aware that changing the service area population will also have an impact on the project's median household income, interest rates, and eligible grant percentage.

By using this option, it will help us to ensure that we are including all rural residents that will be served by these facilities.
