**SUBJECT:** Results of the 2017 Multi-Family Housing  
Annual Fair Housing Occupancy Report

We are pleased to present the 2017 Rural Development Multi-Family Housing (MFH) Annual Occupancy Report, which includes both Rural Rental Housing (RRH) Section 515 and Farm Labor Housing (FLH) Section 514 properties. These results are based on September 2017 data from the Multi-Family Information System database.

This report presents data from the past three years, comparing information from years 2015 to 2017. Attachment A is a summary of report results. Highlights of this year's data include:

- The total number of rental properties has decreased by 1.94 percent since last year or a decrease of 246 Section 515 properties and a decrease of 32 FLH properties. The number of rental units in the MFH portfolio has decreased by 1.17 percent. Overall, we saw a reduction of 278 properties in the past year, representing 5,053 apartment units.
- The current population shows a continued decline in the White population from 67.03 percent to 65.99 percent. The breakdown now consists of:
  - White, Non-Hispanic households: 65.99 percent;
  - Black, Non-Hispanic households: 19.66 percent;
  - Hispanic households: 11.50 percent;
  - Asian, Pacific Islander households: 0.72 percent;
  - American Indian/Alaskan Native households: 1.55 percent;
  - Multi-Racial households: 0.58 percent.
- There was a slight decrease in very-low-income households, which represent 91.67 percent of all households. Low-income households represent 7.10 percent of the total.

- Average household incomes are up to \$13,181 from \$12,960 (a 1.71 percent increase); the average income of Rental Assistance (RA) households increased to \$10,897 from \$10,732 (1.54 percent increase).
- Female-headed households continue to represent the majority of households (71.0 percent). There was no appreciable change in the percentage of elderly persons with disabilities households vs. non-elderly, but the persons with disabilities population continue to increase within the elderly/disabled households.
- Overall, as a percentage of all households, female-headed households remained approximately the same; there was a slight increase in elderly households; and more disabled households. Generally, over the last several years, the portfolio continues to favor elderly/handicapped vs. non-elderly households.

In comparing the RRH Section 515 portfolio with the FLH Section 514 portfolio, it is interesting to note:

- FLH members per household are about twice the size of the average household in the portfolio. Average farm labor income is more than one and half times that of the average RRH portfolio household (\$24,070 vs. \$12,776). Farm labor income for RA households, \$17,302, is significantly higher than the average RA income for the RRH portfolio, \$10,658.
- Elderly/disabled households make up 63.69 percent of the RRH portfolio, but only 21.77 percent of the FLH households.
- RA households make up 67.9 percent of the RRH portfolio and 68.2 percent of the FLH households. RRH showed a slight increase and FLH showed a slight decrease in RA households compared to last year. Overall, 81 percent of households continue to receive some subsidy.
- White households constitute 68.2 percent of the RRH portfolio, while minorities constitute 94.4 percent of the FLH households.

The report shows a decrease in the number of households classified as being rent overburdened (those paying more than 30 percent of their income towards rent) by almost 4 percent. This decrease indicates that RA units continues to be maximized to assist eligible tenants.
