### EDUCATION FOUNDATION PROUDLY ANNOUNCES AWARDING 44 SCHOLARSHIPS FOR 2008-2009

July 29, 2008, Alexandria, VA - At the annual NAHMA Summer Meeting held in Vail, Colorado, the Educational Foundation announced the outcome of the scholarship competition for the 2008-2009 school year. Forty-four scholarships totaling \$50,000 will be provided to worthy students.

Wayne Fox, Chairman of the Foundation indicated, "We are very, very pleased to have significantly increased the number and overall value of the scholarships. In 2007, the Foundation awarded twenty-two scholarships each worth \$1,000. This year, we were able to double the number of scholarships and more than double the amount of money awarded." This program expansion is directly attributable to the increased funding made available through the generous donations of JeffCo Housing; Freddie Mac; SPI; and the many "Friends of the Foundation" gifts received over the last several months.

Over 100 applications were received yielding 81 fully complete and eligible applications to be considered by the committee. Applications were received from 23 different states and the Virgin Islands. Submissions came from twelve different AHMAs and 31 different management companies were represented. Sixteen of the applicants were single parents; thirty-four came from applicants over the age of twenty-four; eight individuals held Associate's degrees from community or junior colleges and are continuing their education at a four year institution; and, one applicant held a GED. Ten of the 2007 recipients reapplied for consideration in 2008, seven of those individuals had grade point averages above 3.0 and the other three were all substantially above the Foundation's grade point average cutoff of 2.3 for matriculated college students."Our goals for the program in 2009, include expanding our application pool by securing submissions from all nineteen AHMAs, and to again, increase the number and amount of the awards," Fox stated. "We hope that all NAHMA members are proud of this terrific resident benefit program. The Foundation believes that the scholarship program is helping to change and redefine the lives of residents."
