### **Hear from Affordable Housing Experts at NAHMA's Federal Affairs Issues Meeting**

*Alexandria, Va., Jan. 29, 2015* — Time is running out to receive the early bird discount for the National Affordable Housing Management Association (NAHMA)'s Federal Affairs Issues winter meeting, March 8-10, in Washington, D.C. [Register](#) before Feb. 6 to receive the reduced rate and avoid higher on-site registration fees.

The three-day event features educational panels, networking opportunities, industry awards, Communities of Quality (COQ) awards luncheon and keynote speaker. The event concludes with prearranged Capitol Hill meetings with congressional representatives and their staff. Event registration includes admission to the COQ luncheon, Monday, March 9.

The annual forum features a number of educational panels specifically geared toward the affordable housing industry and are led by the people who are experts in their fields. Take part in discussions on Department of Housing and Urban regulatory issues; Tenant Rental Assistance Certification System (TRACS) and contract administration; Fair Housing trends; affordable housing industry's congressional priorities; rural housing; tax credit issues and senior housing.

The panelists leading the discussions include HUD personnel from the offices of Multifamily Housing; Public and Indian Housing; Asset Management and Portfolio Oversight; Program Systems Management. Additional experts include specialists from the U.S. Department of Agriculture and IRS, as well as industry authorities from the Fair Housing Institute Inc.; National Leased Housing Association; National Apartment Association; The Council for Affordable and Rural Housing; LeadingAge; National Council of State Housing Agencies and the Gates Dunaway Group.
