

Online Registration for the NAHMA March Meeting Closes Next Week and Room Block Expires This Thursday

Alexandria, Va., Feb. 19, 2020 — Online meeting registration for the 2020 National Affordable Housing Management Association (NAHMA) Biannual Top Issues in Affordable Housing <u>winter conference</u> closes Friday, Feb. 28. <u>Register</u> for the NAHMA meeting today and avoid the additional on-site charge. Furthermore, the discounted room block has been extended through tomorrow, Feb. 20, and must be booked through email. The room reservation requires a separate registration from the NAHMA meeting.

Please note, the room reservation link is experiencing issues. The discounted rooms are booked on a first-come, first-served basis and expire on or before Feb. 20, depending on availability.

With a focus on the top issues facing affordable housing, the winter meeting takes place at the Fairmont Washington, 2401 M St. NW, Washington, D.C., March 8-10. The three-day NAHMA March meeting features educational panels, networking opportunities, the Communities of Quality (COQ) Awards luncheon and the Industry and AHMA Awards evening reception. The event concludes with prearranged Capitol Hill meetings with congressional representatives and their staff.

The annual conference features a number of educational panels specifically geared toward the affordable housing industry that are led by the people who are experts in their fields. This year's confirmed guests include Anna Maria Farias, Department of Housing and Urban Development (HUD) assistant secretary, Fair Housing and Equal Opportunity; Adrienne Todman, CEO of the National Association of Housing and Redevelopment Officials; Brenda Harrington, certified executive coach; and Dena Calo, Esq., human resources strategist and employment attorney, as well as senior HUD leadership and policy staff from Multifamily Housing, industry experts on the Community Reinvestment Act, and senior leadership from the Department of Agriculture's Rural Development. Panels featuring government officials and other special guests are not open to the media and may not be recorded.
