Alexandria, Va., Jan. 26, 2022 — The National Affordable Housing Management Association (NAHMA) is looking forward to welcoming members and other industry partners to its Biannual Top Issues in Affordable Housing [winter conference](#) at the Fairmont Washington in Washington, D.C. Unlike in-person meetings of the past, we will be gathering Wednesday through Friday. The multiday event, March 9-11, will feature panels concentrating on the issues facing affordable housing practitioners and educational topics for navigating today's world led by experts in their fields. The meeting will be mandated to comply with the D.C. government coronavirus requirements for large gatherings. The annual meeting features several educational panels geared explicitly toward the affordable housing industry. Invited guests include representatives from the Housing and Urban Development and Agriculture departments and more. Panels featuring government officials and other special guests are not open to the media and may not be recorded. Event registration includes admission to all sessions and open committee meetings, the Communities of Quality Awards luncheon and panel discussion, and the Industry Awards ceremony. Both awards celebrations take place Thursday, March 10.

The winter meeting takes place at the Fairmont Washington, 2401 M St. NW, Washington, D.C., March 9-11. The NAHMA room block single/double rate is \$369. The discounted rooms are booked on a first-come, first-served basis and expire on or before Feb. 14, depending on availability. Beginning Jan. 15, 2022, specific D.C. public businesses—including, but not limited to, indoor food and drink establishments, and hotel meeting rooms, ballrooms, fitness centers and hotel restaurants and bars—will require all patrons aged 12 years old or older to show proof that they have received at least one dose of the COVID-19 vaccine before they are allowed entry. Two doses will be required starting Feb. 15, 2022.
