Unlike past in-person meetings, we will be gathering Wednesday through Friday. The multiday event, March 9-11, will feature panels concentrating on the issues facing affordable housing practitioners and educational topics for navigating today's world led by experts in their fields. Both awards celebrations take place Thursday, March 10. The meeting will be mandated to comply with the D.C. government coronavirus requirements for large gatherings.

The annual meeting features several educational panels geared explicitly toward the affordable housing industry. Invited guests include representatives from the Housing and Urban Development and Agriculture departments and more. Panels featuring government officials and other special guests are not open to the media and may not be recorded. Event registration includes admission to all sessions and open committee meetings, the Communities of Quality Awards luncheon and panel discussion, and the Industry Awards ceremony.

The winter meeting takes place at the Fairmont Washington, 2401 M St. NW, Washington, D.C., March 9-11. The NAHMA room block single/double rate is \$369. The discounted rooms are booked on a first-come, first-served basis and expire on or before Feb. 14, depending on availability. Members planning to attend the meeting need to be aware that the District of Columbia has specific requirements to combat COVID that all visitors will need to abide by. At the time of our meeting, specific D.C. public businesses—including, but not limited to, indoor food and drink establishments, as well as hotel meeting rooms, ballrooms, fitness centers and hotel restaurants and bars—will require all patrons aged 12 years old or older to show proof that they have received at least two doses of the COVID-19 vaccine before they are allowed entry.
