SUBJECT: Results of the 2022 Multi-Family Housing Annual Fair Housing
Occupancy Report

We are pleased to present the 2022 Rural Development Multi-Family Housing (MFH) Annual Occupancy Report, which includes both Section 515 Rural Rental Housing (RRH) and Section 514 Farm Labor Housing (FLH) properties. These results are based on October 2022 data from the Multi-Family Integrated System (MFIS) database.

This report presents data from the past three years, comparing information from years 2020 to 2022. Attachment A is a summary of report results. Highlights of this year's data include:

- The total number of rental properties continued to decrease from October of 2021 to 2022. The total portfolio was reduced by 158 Section 515 properties and 7 Section 514 FLH properties.
- The properties lost caused a 0.77% decline in the number of rental units available in the MFH portfolio. This is a decrease of 3,154 affordable apartment units.
- Race/ethnicity of tenant households remains similar to previous years, and consists of:

White, Non-Hispanic households:	64.42 percent
Black, Non-Hispanic households:	20.40 percent
Hispanic households:	12.05 percent
American Indian/Alaskan Native households:	1.66 percent
Multi-Racial households:	0.78 percent
Asian, Pacific Islander households:	0.69 percent
- The vast majority of households, 92.3%, are very-low income. Low-income households represent 6.7% of the total households.
- Average tenant household income has increased 5.7% to \$15,502 in 2022. The average income of Rental Assistance (RA) households increased to \$12,989 from \$12,501, a 3.9% increase.
- Most households continue to be female-headed, 70.7%.

In comparing the Section 515 portfolio with the Section 514 portfolio, it is interesting to note:

- FLH households are larger on average, about twice the size of the average household in the portfolio. Average FLH income is almost twice as much as the average Section 515 household (\$29,683 vs. \$14,941). FLH income for RA households of \$20,786, is significantly higher than the average RA income for the rest of the portfolio, \$12,708.
- By elderly definition 64.8% of the RD portfolio units are home for elderly, handicapped, or disabled, but only 25.7% of the FLH households have that status.
- RA households make up 75.6% of the total RD portfolio but 68.7 percent of the FLH households.
- The majority, 93.7% of the 514 FLH households are households of color, compared to the only 35.6% of the overall RD portfolio.

Eighty-eight percent of tenants in the RD portfolio are receiving some type of tenant subsidy, with 85% of those households receiving Rental Assistance through RD. Households that are overburdened, or paying more than 30% of their income from rent, are only 1.4% of the RRH portfolio.
