### **SHCM Exam In Person Proctoring**

The student will find a SHCM, NAHP, or NAHP-e certified person from within their company or even a manager or supervisor which can act as a proctor or the online credential directory at <a href="http://www.nahma.org/directory">http://www.nahma.org/directory</a>. As an alternative, you may also contact your local AHMA for assistance in locating a proctor for your retake exam. Include the proctors' contact information on the retest form and refer the proctor to Leslie O'Donnell at NAHMA (703-683-8630 ext 117) for steps to administer the exam. Also, email a request for a (voucher) to lodonnell@nahma.org which is needed to access the online exam at least five days after your retest form is submitted. The student coordinates with the proctor the test date/time and location. The exam can be taken on a computer at the home office or even property. Desktop computer, laptop or even a tablet.

### **SHCM Exam Online Proctoring**

NAHMA has elected to use web-cam proctoring services and have partnered with Examity to offer those services. Web-cam proctoring offers the ability for you to test from home or any location of your choice. The date and time that you can take the examination is subject to availability of the virtual proctor. Exam appointments must be booked in advance. When scheduling your exam appointment please allow a minimum of 14 working days to ensure testing availability.

To take the SHCM exam your computer should meet the following criteria.

- A well-working computer connected to a power source with 1 GB of RAM or higher.
- A wired high-speed internet connection (3 Mbps). A wireless internet connection is not recommended if an Ethernet connection is available.
- A camera, microphone and speakers connected to the computer (consider a webcam with a built-in microphone).
- Online Live Proctoring will be done through the GoToMeeting platform.\* Please be sure your system will support this platform.

The proctor will need to obtain keyboard and mouse controls in order to input proctor information. \*Please make sure that your system that you will be using to test will allow you to grant these permissions to the proctor.
