Hard copies of the meeting materials will not be available. The multiday meeting, taking place March 19-21 in Washington, D.C., will highlight panels concentrating on affordable housing practitioners' issues and educational topics for navigating today's world led by experts in their fields. The NAHMA [meeting app](#) includes a schedule of all the sessions with their corresponding course materials, speakers, meeting sponsors, and new NAHMA members, as well as an opportunity for conference participants to post photographs and messages on the app's social feed. A list of attendees will be uploaded once the online registration for the meeting closes next week. The app is being updated as materials become available. To use the NAHMA March meeting app, Yapp—which can be found in your mobile device's app store—must be installed on your phone or tablet. Once the app is downloaded, you can create a log-in to update your profile, add a photo, and contact fellow attendees.

The annual meeting features several educational panels geared explicitly toward the affordable housing industry. Bob Simpson, the president of the Multifamily Impact Council, will provide the keynote address. Invited guests include representatives from the Housing and Urban Development and Agriculture departments and more. Panels containing government officials and other special guests are not open to the media and may not be recorded. Event registration includes admission to all sessions and open committee meetings, the Communities of Quality Awards luncheon and panel discussion, and the Industry Awards ceremony.
